- IV. Reports
 - A. Service Employees International Union (SEIU) Local 2015- Deborah Hibbler three timesheet trainings were presented in February. An additional FLSA/Timesheet/Appeals training will be held on March 18 at 6:00 pm. SEIU Local 2015 has a new office: 681 West Capitol Avenue, West Sacramento, CA 95605.
 - B. Adult and Aging Commission Dr. Marshall Gordon: Adult and Aging Commission is currently going through a redesign to provide better communication and assistance to the Adult and Aging community. The Adult and Aging Commission sponsored a community town hall meeting which provided information about services offered in the County of Sacramento. - C. Department of Health and Human Services (DHHS) Senior and Adult Services, Sandy Deutsch, IHSS Supervisor
 - New IHSS Staff Changes:
 - New Supervisor: Courtney Washington
 - New Social Worker: Lyudmila
 - Yolanda's Intake unit has vacancies (staff moved to Courtney's continuing case worker unit)
 - Courtney now has 7 continuing case workers. Fair Labor and Standards Act (FLSA) Unit has 3 workers, 1 supervisor requesting more positions from the board before July. There will be continuing FLSA support through IHSS (916) 874-9471, select Payroll.
 - Jeannette Johnson's former position going to the board week of 3-14-16 to request reallocation from ½ time to full-time.
 - Other Changes:
 - Debra Morrow retired; Debbi Thompson is the new Senior and Adult Services Division Manager.
 - Mike Andreozzi, IHSS Program Planner, retired and is replaced by Cindy Wang.
 - Ethane Smooth, IHSS Program Secretary, retired, replacement pending

March is National Social Worker Appreciation month. A breakfast was held to recognize the contribution of IHSS Social Workers. The focus of recognition was empowerment, enrichment, appreciation.

D. Public Authority: Rick Simonson, Executive Director, IHSS Public Authority-

Budget report is in meeting materials.

The Governor has signed into law a new Managed Care Organization (MCO) Tax which will generate between \$1.3 to \$1.7 billion in additional revenue for California. The current MCO tax expires in June 2016. The implementation of the new MCO tax will assure that the 7% in reinstated hours for IHSS recipients will remain in place.

FLSA – changes are rolling out. These changes include overtime over 40 hours a week, wait-time at medical appointments and travel time between IHSS recipients, all with limits. A letter from the IHSS Coalition (in meeting materials) expresses some concerns and make recommendations about the FLSA rollout. There are two organizations that regularly update about IHSS/FLSA matters where up-to-date information can be found: Marty Omoto – advocate for seniors and persons with disabilities (www.cdcan.org); and Disability Rights California (www.disabilityrightsca.org).

IHSS Public Authority will continue to provide timesheet information during new provider orientations. There is also a state video online explaining FSLA changes at: <u>http://www.cdss.ca.gov/agedblinddisabled/PG3154.htm</u>.

The IHSS Coalition is asking for reinstatement of the IHSS share of cost buy out. Medi-Cal has a threshold amount of \$889.40 in income; if a recipient has more than the income threshold then they will have a Medi-Cal share of cost paid down to the IHSS share of cost amount of \$600. When a recipient has a Medi-Cal share of cost, the recipient must pay the provider out of pocket for the share of cost. The share of cost buyout would reinstate a program that paid the difference between the Medi-Cal (\$889.40) and the IHSS (\$600) share of cost (handout in meeting materials).

The State of California budget hearings are being held in March and April. They are televised at: www.calchannel.com.

The 13th annual Disability Capital Action Day (DCAD) is May 26, 2016, and will be held at the State Capital. The California IHSS Consumer Alliance (CICA) will hold a summit the day before on May 25, 2016 in Sacramento. (NOTE: Since the IHSS Advisory Committee meeting, both of these events are being rescheduled in the fall.)

Thursday March 24, 2016, bargaining begins with SEIU 2015 toward a successor labor agreement.
