V. Committee Matters -

IHSS Member Concerns:

CDSS communication about overtime, travel time and wait time has not been clear or complete. What happens when a provider must use available hours waiting at a medical appointment and there is no longer time to deliver other IHSS services?

The changes related to Fair Labor Standards Act (FLSA) move away from self-direction rather than toward self-direction. This is beginning to feel like being institutionalized at home.

FLSA limits create great difficulty for IHSS consumers when the most available individual can no longer do the job.

FLSA limits may impact eligibility for health benefits.

If an IHSS recipient has waiver hours, does the total number of available hours increase to 360 hours per month?

The Labor Commission is suing an IHSS recipient for pay owed by the IHSS program.

Can Sacramento County print timesheets? (Replacement timesheets are available from IHSS Payroll).
