C. Department of Child, Family and Adult (DCFAS) Senior and Adult Services – IHSS is finally available to hire 12 social workers, supervisors, planners, and program specialists, (20 total positions). We did not fill vacancies we had an internal freeze and have been slow to fill positions. Sick time for providers goes into effect on July 1, 2018. Unsure if a provider receives their 8.0 hours of sick, will it drop off if the provider does not have 200 hours or 60 days prior to the June 30, 2019, use or loose date.. Provider will receive a mailer with a sample sick leave timesheet. We are going out to vulnerable clients during the heatwaves.

D. Public Authority: John Kozitza, Interim Executive Director, IHSS Public Authority: Budget 2018-19, no fiscal impact. Christine form UEW stated – Dues will no longer be taken from providers checks. Basically this appears to

be a way to tear down the unions. Many people believe IHSS is a welfare program and don't realize it is a program to keep people safely in their homes.
