- A. DHHS Senior and Adult Services, Sandy Deutsch:

Fair Standards Labor Act (FSLA) – Provides overtime for providers was initiated by the Labor department. CDSS originally hired a unit to handle FSLA.FSLA was approved but then a stay happened so the Labor Standards took the issue to the Supreme Court, again it was approved and re-appealed. There is currently a stay could last until 2017.

To become an Intake screening –Social Services Worker (4 years of college masters in social work), eligibility specialist –entry level, intake taking about 30 days to for the social worker (Social Services Worker - 4 years of college masters in social work,

eligibility specialist) to come out to home. Then the consumer will move to a continuing case worker.

Currently, some employees are telecommuting to work, working 10/4, and 9/80 schedules.

B. Public Authority: Rick Simonson, Executive Director, IHSS Public Authority-

Continuing to prepare larger space for orientation and planning to move to new orientation room within the next 2 weeks.

Registry orientation:

- a. Registry applicants must attend two 2.5 hour classes on Wednesdays and Thursdays at 1:00 p.m., and a scheduled morning provider enrollment orientation.
 - i. Wednesday first class
 - 1. Pretest
 - 2. Watch 3 videos
 - 3. Come with completed applications and references
 - ii. Thursday second class
 - 1. Videos
 - 2. Post test
 - 3. Schedule Provider Enrollment Orientation/Interview
- b. Orientation 9:00 a.m., Tuesday, Wednesdays, and Thursdays
 - i. Orientation
 - 1. Scheduled for a 9:00 a.m. orientation Tuesday, Wednesdays, and Thursdays, and an individual interview

As part of successor planning, several staffing changes are recommended: – Administrative Services Officer (ASO) I position reallocated to an ASO III who will handle accounting, budget, contracts, and provide expert level administrative support to the Executive Director. . ASO I position will be reallocated to an ASO II and will oversee the provider enrollment process including orientations, DOJ background checks and waivers. .

If/when the statewide bargaining goes into effect then the new union will negotiate with the State of California, PA may be invited to advise the state on local matters. Although a statewide bargaining Public Authority may be created, it is unlikely that a statewide wage will be established.

All county letter No 1-70-15 (link provided) looks at the IHSS program from 2001 - 2013.

Year-end budget report for 14-15 enclosed, The same budget is proposed for Fiscal Year 15-16. Some years ago the IHSS Advisory Committee's budget was \$58,000; now their annual budget from the state is \$5,916.
